**Renewal Of Registration For Temporary Registered Quantity Surveyor For The Year 2011**

Please be informed that your registration as a Temporary Registered Quantity Surveyor with the Board of Quantity Surveyors Malaysia (BQSM) will expire on 31.12.2010 and has to be renewed for the year **2011**. Therefore, you are required to renew your registration with the Board before **31.1.2011**. With effect from year 2010 renewal of registration, the Board has decided to make it **mandatory** for members to renew their registration **online** using ReQSys application in BQSM website, <http://bqsm.gov.my/reqsys/public/user/login.php>. Please take note that your renewal application will not be considered if you do not renew your registration online even if the Board receives the renewal fees and your CPD requirement is sufficient.

2. To renew your registration, please follow the steps in Appendix A/2011/MT.
3. Please take note that all Temporary Registered Quantity Surveyor's renewal application must be endorsed by a Local Sponsor before the application for renewal can be considered by the Board. The endorsement can be made online during renewal application.
4. We are also pleased to inform that the Board has approved the issuance of **one CPD discount voucher valued at RM50.00** to Temporary Registered Quantity Surveyors who have fulfilled the renewal requirements and who have submitted their renewal fee and application for renewal before or on 31.12.2010 as an incentive for early bird renewal of registration. This CPD discount voucher will be effective for a period of one year from 01.01.2011 to 31.12.2011 and it is non-transferable. This CPD discount voucher can only be used for CPD programmes organized by the Board.
5. Uncompleted submission of renewal or all renewal applications received before or on 31.01.2011 but without complete documentations (e.g. payment, copy of certificate of attendance in CPD programme for the year 2010) shall be tabled at the Board Meeting scheduled in February/March for cancellation and you shall be imposed a re-registration fee as stated in para 7 below.
6. **If you fail to renew your registration with the Board by 31.1.2011, your registration will be automatically cancelled by the Board with effect from 1.2.2011 and action will be taken to delete and remove your name from BQSM's Register. It is illegal for you to practise and provide services as a Temporary Registered Quantity Surveyor in Malaysia pursuant to Section 8 of the Quantity Surveyors Act 1967.**

7. For 2011 reinstatement application, please apply online. 10 CPD credit points is required together with the following payment (pursuant to Rules 23 (B), Quantity Surveyors Rules 1973 and (Amended) Rules 2004):

i)	Renewal Fee 2011	-	RM3,000.00
ii)	Reinstatement Fee	-	RM3,000.00
iii)	Administration Fee (non-refundable)*	-	<u>RM 50.00</u>
	<b>Amount payable</b>	-	<b><u>RM6,050.00</u></b>

**8. Please take note that pursuant to Section 17 (2) of the Quantity Surveyors Act, if a Temporary Registered Quantity Surveyor failed to renew his/her registration for a duration of more than 3 years, he /she will be required to submit a new application to the Board (based on latest conditions).**
