**CIRCULAR NO. 4/99**

**COMPULSORY CONTINUING PROFESSIONAL DEVELOPMENT (CPD) FOR REGISTERED QUANTITY SURVEYORS**

The Registration of Quantity Surveyors Act 1967 is being amended and inter-alia to introduce an enabling provision to facilitate the implementation of Compulsory CPD as additional conditions for renewal of registration for both provisionally and fully Registered Quantity Surveyors.

The Board of Quantity Surveyors Malaysia in its meeting on 16 October 1999 has decided to impose Compulsory CPD for all Quantity Surveyors registered with the Board as a condition precedent to renewal of registration **with effect from 1 January 2002.**

Commencing year 2001, all Quantity Surveyors will have to participate and maintain records of their participation in the Compulsory Continuing Professional Development programmes in order to be able to renew their registration. Beginning year 2002, all renewals of registration with the Board must include evidence that they have undertaken and accumulated a minimum of ten (10) CPD credit hours in the preceding year. Failure to satisfy this minimum requirement will result in the rejection of your application for renewal of your registration.


The Compulsory CPD requirement for Registered Quantity Surveyors will be implemented by the Joint BQSM/ISM Compulsory CPD Committee.

As an introduction to this CPD programme, the Board has also decided to allow Registered Quantity Surveyors to accumulate CPD credit hours for the year 2000 and 2001 for the renewal of registration for the year 2002. In connection therewith, the launching of Compulsory CPD will be held in January 2000. All Quantity Surveyors are strongly advised to participate actively in the CPD programmes to equip and update themselves with the latest knowledge and developments in the QS profession.

The time and venue of the launching of the Compulsory CPD will be advised later. ## LEMBAGA JURUUKUR BAHAN MALAYSIA

#### **COMPULSORY CONTINUING PROFESSIONAL DEVELOPMENT (CPD) UNTUK JURUUKUR BAHAN BERDAFTAR**

---

Akta Pendaftaran Juruukur Bahan 1967 kini sedang dipinda dan salah satu pindaan tersebut adalah untuk memperkenalkan satu peruntukan bagi melaksanakan *Compulsory CPD* sebagai satu syarat bagi pembaharuan pendaftaran kedua-dua Juruukur Bahan Berdaftar dan Juruukur Bahan Berdaftar Sementara.

Lembaga Juruukur Bahan Malaysia (LJBM) di dalam mesyuaratnya yang diadakan pada 16 Oktober 1999 telah memutuskan untuk mengenakan *Compulsory CPD* untuk semua Juruukur Bahan yang berdaftar dengan LJBM sebagai syarat untuk pembaharuan pendaftaran **berkuatkuasa mulai dari 1 Januari 2002.**

Mulai dari tahun 2001, semua Juruukur Bahan hendaklah menyertai dan menyimpan rekod mengenai penyertaan mereka di dalam program-program *Compulsory Continuing Professional Development* untuk membolehkan mereka memperbaharui pendaftaran mereka. Mulai tahun 2002, semua pembaharuan pendaftaran dengan Lembaga mesti mengandungi bukti bahawa mereka telah mengambil bahagian dan mengumpul sekurang-kurangnya sepuluh (10) jam kredit *CPD* pada tahun sebelumnya. Kegagalan mematuhi keperluan syarat minima ini akan mengakibatkan permohonan pembaharuan pendaftaran ditolak.

Keperluan *Compulsory CPD* bagi Juruukur Bahan Berdaftar akan dilaksanakan oleh Jawatankuasa Bersama *Compulsory CPD* LJBM/ISM.

Sebagai pengenalan kepada program *CPD* ini, Lembaga telah membenarkan Juruukur Bahan Berdaftar untuk mengumpul jam kredit *CPD* mereka dalam tahun 2000 dan 2001 bagi pembaharuan pendaftaran tahun 2002. Sehubungan dengan itu, perancangan *Compulsory CPD* akan diadakan dalam bulan Januari tahun 2000. Semua Juruukur Bahan Berdaftar dinasihatkan untuk mengambil bahagian secara aktif di dalam program-program *Compulsory CPD* demi untuk melengkap dan mengemaskini diri dengan pengetahuan dan pembangunan yang terkini di dalam profesion Ukur Bahan.
